## **The Important Fine Print & Trip Cancellation Information**

**European Adventure to Garmisch-Partenkirchen, Germany, Southern Spain – Seville, Malaga, & Barcelona  
March 3 to 11/24, 2018**

Fees, rates, and specifications are subject to change. Prices quoted are per person, based upon special rates negotiated with the airlines and other suppliers. Space and rate are subject to availability at the time of booking and subject to change until space is confirmed. The air tickets issued are individual, restricted economy class, non-refundable, require a fare guarantee deposit (included in your first deposit), and advance purchase. Prices quoted for Europe are based upon a group size of 18 or more people registered by August 30, 2017. Should the group size decrease below 18 people for any segment a rate increase of \$95 will occur. Should the group size decrease below 14 people for any segment a rate increase of approximately \$195 will occur. Should the group size decrease below 11 people for any segment a rate increase of approximately \$295 will occur, or at the option of Alpine Adventures and/or Ski Europe, that segment may be cancelled. Conversely, should the group size increase from one rate tier to another, a credit will be issued.

The current total fee for US and foreign departure taxes, security fees, fuel surcharges, and passenger facility charges (Airport taxes and fees) is \$434 to \$467 – depending on itinerary - and is included in the trip fee. This fee is subject to change. Other fees that may be imposed by the airlines or other authorized agencies are not included. Rates are based on the Euro exchange on June 25, 2017, and are subject to adjustment should an increase of 1.25% or greater occur. Rates include all fees for payment processing. A discount is applied to your trip fee if paying by cash or check.

The final occupancy of a lodging unit determines the rate per person. Please note that single rooms are usually smaller than double rooms. Your balance is due on November 5, 2017, and will be based on the on the group size, rooming arrangements, and exchange rate at that time (excluding fees guaranteed by early deposit). A late fee of \$150 will be imposed for balance payments received after November 5, 2017, and all airline tickets reserved in your name will be subject to cancellation. Adjustments to your balance caused by changes in the airport fees, exchange rate, rooming arrangements, or group size, may occur after November 5, 2017, and will be credited back, or due before departure.

**Nobody wants to cancel from a trip, but sometimes circumstances arise that can keep you from traveling.  
If you must cancel from this trip, the following fees will be imposed:**

Your deposit, less a \$75 administrative fee and \$150 fee imposed by our tour suppliers (total \$225), plus any non-refundable portion of airline tickets, is refundable if written notice of cancellation is received before September 24, 2017.

**For cancellations received:**

**160 (9/24/17) to 120 days** before departure the fee is \$500 or 15% of the trip fee whichever is greater.

**119 (11/4/17) to 70 days** before departure the fee is \$1950 or 50% of the trip fee whichever is greater.

**From 69 (12/24/17) days** or less before departure and "No Shows", no refund will be given.

Additional charges will be imposed by the various lodging, (including fees incurred due to the reduction of people in a specified lodging unit, and upgrade fees) resort, and transportation vendors, and are not included in the above fees. Be aware that refunds from vendors (when given) are slow and usually take 90 to 120 days, but in some cases may take as much as 180 days or more. There are no refunds for unused portions or services. All cancellations must be in writing and delivered to the Alpine Adventures office. The date of receipt in the Alpine Adventures office determines the effective date of cancellation. If submitting cancellation electronically, notice of cancellation is not valid until a confirmation of receipt is delivered to the sender. **Trip cancellation insurance is available and strongly recommended.**

Name Changes - The name supplied to the airlines must match the legal name on the traveler's passport. Changes may incur substantial penalties by the airlines, which we must pass on to the traveler. Any name change requests must be submitted in writing to our office.

Tour Supplier - Most of the travel arrangements and lodging reservations for this trip are made through the same organization we use for the majority of our European trips, Ski Europe.
